



## Membership Rules for Scuderia Ferrari Club Melbourne

### 1. Definitions

- 1.1 'SFCM' shall mean Scuderia Ferrari Club Melbourne
- 1.2 The 'Club' is the Scuderia Ferrari Club Melbourne
- 1.3 'Committee' means the committee of management of the SFCM
- 1.4 'Month' shall mean a normal calendar month
- 1.5 'Membership fee' is the amount payable to the SFCM in \$AUD via the appropriate option(s) available at that time e.g. cash, cheque, EFT, Paypal (to be developed)
- 1.6 'Membership Term' is the period commencing 1<sup>st</sup> April and ending 31<sup>st</sup> March the following year.

### 2. Objects or purposes of the Club

- 2.1 Formation of a social Club of like minded people that have a passion for the Ferrari Formula 1 team
- 2.2 Social activities/gatherings to include such things as (but not limited to) galas, functions, sporting activities, F1 events and business networking meetings
- 2.3 Promotion of Ferrari F1 merchandise
- 2.4 Provide a source of Ferrari F1 news for members.

### 3. Club Operation

- 3.1 The Club and its parent company, **Rosso Sportivo Ltd**, will operate in accordance with its constitution as registered under the Australian Corporations Act 2001.

### 4. Membership Status

- 4.1 **Full Member** – Must be over 16 and can partake in any event organised by the SFCM
- 4.2 **Junior Member** – Must be under the age of 16 and can partake in any event SFCM organises unless an age restriction applies according to state and/or federal law
- 4.3 **Additional Member** – May be under or over 18 years of age and is subject to the same allowances provided for a Full or Junior member. An adult *Family Member* is deemed an "Additional member" by default unless they specifically request to be a Full Member



### ***Membership Terms, Conditions and Fees***

- 4.4 *Membership fees* are due by the 1st April of each year, in order to have membership benefits for that membership year. The *Membership Term* will take effect regardless when the *Membership fee* was originally paid. Consequently, this means that an annual subscription will lapse the 31st of March every year
- 4.5 If you are successful in your Membership application, the *Club* will issue you a payment confirmation electronically or otherwise, within 5 business days. Your membership card and fulfilment package will be issued to you post registration. The *Club* will endeavour to provide the membership kit ASAP, however delays may occur depending upon time and order constraints at Scuderia Ferrari Club (Maranello) of which is outside the direct control of *Scuderia Ferrari Club Melbourne*
- 4.6 The *Club* reserves its right not to accept any Membership application in its absolute discretion
- 4.7 All *Membership fees* are reviewed annually and may be adjusted according to the financial requirement of the *Club*. Members will be advised of any adjustments
- 4.8 Additional fees and/or charges may be requested for participation in functions/events being organised by the *Club*. However, these will be optional and payable by the member only if they wish to participate in the function/event
- 4.9 *Membership fees* will be advised to current or prospective members prior to joining or renewing membership with the *SFCM* for that *Membership Term*
- 4.10 Any Member whose subscription is outstanding for more than 30 days after the due date, may have their membership revoked at that time, unless prior arrangements are made with *Club Committee*
- 4.11 The Club Committee may choose to reinstate a membership on normal Membership Terms, with expiration to be the normal Membership Term as noted in 4.1 above.
- 4.12 A membership may be rescinded at any time, by giving written notice to the secretary or President of the *Club*. Should a member choose to do this, they immediately forgo any membership subscription that has been paid for that *Membership Term*
- 4.13 *Club* Membership cards and associated benefits are for personal use only and may not be transferred to another person under any circumstances. Lending a *Club* Membership card, or in any other way transferring *Club* Membership benefits to another person, is a breach of *Club Membership Terms* and conditions and penalties may apply (including cancellation of the offending person's *Club* Membership). The *Club* Membership card remains the property of the *Club*
- 4.14 No On selling. *Club* memberships, membership cards and related benefits may not be on sold (including via on-line auction sites) or used for advertising, promotion or other commercial



purposes (including competitions and trade promotions) or to enhance the demand for other goods or services, either by the original purchaser or any subsequent bearer. If a membership, card or benefit is on sold or used in breach of this condition, the membership may be cancelled, without a refund (refer to 5.17 Cancellation Policy)

4.15 Payment of your *Club* Membership subscription may be made in full via any one of the following methods – Cash or EFT\*, details of which will be provided to you upon completion and receipt of your completed application.

**\*IMPORTANT** - if making payment by EFT, ensure to add the year in which your membership applies e.g. 2016 as well as your first and last name as reference to the deposit. This way your payment may be acknowledged as having been received

4.16 Except where expressly noted, all prices include GST and any applicable levy

4.17 **Refund Policy.** *Club* Memberships subscriptions are non-refundable and are not payable as a “pro rata” payment. All memberships are payable in full as noted in 5.12

4.18 **Changes to *Club Membership Terms and Conditions.*** The *Club* may review and where reasonably necessary, vary the terms and conditions of *Club* Membership. The *Club* will communicate any change to its *Membership Terms* via email and/or other means when available e.g. website. Members will have no claim against the *Club* by reason of any change made to the terms and conditions of *Club* Membership

4.19 **Lost or Stolen Memberships Cards.** Membership cards remain the property of the *Club*. If a *Club* Membership card is lost or stolen, please contact the *Club* via email [melbourne@sfcscarl.com](mailto:melbourne@sfcscarl.com). The *Club* will then report the loss to SFC Maranello with a request for suitable replacement. Replacement of the card will be subject to supply limitations as outlined in 5.2 above

4.20 **Cancellation Policy.** The *Club* reserves its right to cancel a member's *Club* Membership without a refund where that member is deemed by the *Club Committee* to have breached these terms and conditions (including where that member attempts to transfer or sell their *Club* Membership and/or associated benefits)

4.21 If your Membership is cancelled for any reason, you will not be able to gain any benefits associated with the membership, for the remainder of that *Membership Term*. You may re-apply for the *Membership Term*, provided you comply with the terms and conditions of the membership. But this is solely at the discretion of the *Committee* as outlined in 5.4.

## 5. Members' Privacy

5.1 All personal information will be used in accordance with the SFCM Privacy Policy, a copy of which may be viewed on the SFCM website or obtainable in hard copy or electronic means (as required)



as part of the membership application process. By accepting to become a member and making payment of your subscription fee, you automatically agree to be bound by the personal data policy that is applicable.
